



RBI GRAND MASTER AWARD REGULATIONS 2022

VERSION RELEASED ON 18.09.2022

1. GENERAL CONDITIONS

The purpose of the RBI Grand Master Award Regulations is to establish the framework of rules and regulations applicable to the organization of the RBI Grand Master Award event.

RBI SPORT organizes the RBI Grand Master Award which is property of RBI SPORT and includes the following awards:

- One RBI Grand Master Award for Cross Country Enduro
- One RBI Grand Master Award for Cross Country ATV / Quad
- One RBI Grand Master Award for Cross Country SSV
- One RBI Grand Master Award for Cross Country Cars Open
- One RBI Grand Master Award for Cross Country Cars Limited
- One RBI Grand Master Award for Cross Country Truck
- One RBI Grand Master Award for Extreme Cars Open
- One RBI Grand Master Award for Extreme Cars Limited
- One RBI Grand Master Award for Extreme Truck ≤ 7,5 t
- One RBI Grand Master Award for Extreme Truck > 7,5 t

The RBI Grand Master Award is made of the following three rallies of the RBI Sport calendar and their according classes:

- Fenix Rally
- Rallye Breslau Poland
- Balkan Offroad Rallye

2. ALLOCATION OF AWARD POINTS

2.1. For each RBI Grand Master Award, points are awarded to the competitors for each Event considering the Overall Final Classification according to the following scale/Classification points:

Position	Cross-Country and Extreme
1 st	30 points
2 nd	25 points
3 rd	20 points
4 th	17 points
5 th	15 points
6 th	13 points
7 th	10 points
8 th	9 points
9 th	8 points
10 th	7 points
11 th	6 points
12 th	5 points
13 th	4 points
14 th	3 points
15 th	2 points

2.2. For each Award, points are awarded to each leg for each rally according to this scale:

Leg points:

Position	Cross-Country and Extreme
1 st	5 points
2 nd	4 points
3 rd	3 points
4 th	2 points
5 th	1 point

2.2. For each Award, points are awarded only to competitors who are eligible and participating for that Award. Non-participating competitors may not score points nor deprive participating competitors of points.

2.3. No points will be awarded for the Qualifying Stage.

3. NUMBER OF RESULTS TAKEN INTO ACCOUNT

The final classification of each RBI Grand Master Award is established by considering the total number of Events for each class. The awards are awarded to the Crew with the highest total number of points (see tables Classification points + Leg points)

4. PARTICIPATION

- 4.1. All competitors eligible to participate in the RBI events, meeting the RBI Sporting, Technical, GTC and etc., will score points in the RBI Grand Master Award.
- 4.2. If a competitor doesn't want to participate in the RBI Grand Master Award, they must present a written letter for cancelation on the following email: office@rbi-sport.com
- 4.3. If fewer than three entries are received for a RBI Grand Master Award, RBI Sport reserves the right not to award the corresponding award.

5. PARTICIPANTS WITH EQUAL NUMBER OF POINTS. RULES FOR THE FINAL RBI MASTER AWARD CLASSIFICATION.

- 5.1. The Crew with more classification points from the Overall Final Classifications of the rallies will occupy a higher position in the RBI Master Award Classification.
- 5.2. If there are again Crews with equal classification points after the application of rule in 5.1., the leg points will be decisive. The Crew with more leg points will occupy a higher position in the RBI Master Award Classification.
- 5.3. If there are again Crews with equal points after the application of rules in 5.1 and 5.2, then the points of each single rally will be analysed in order to take a decision for the higher position in the RBI Master Award Classification. Points of Rallye Breslau have the highest priority, because it is the biggest of the 3 events with the largest competition.
- 5.4. Decisive for the allocation of the points is the pilot of the Crew.

6. AWARDS/PRIZES

Winners in the RBI Grand Master Awards in each class will receive the following prizes/vouchers:

- 500, - euro voucher for Cross Country Enduro.
- 500, - euro voucher for Cross Country ATV / Quad
- 1000, - euro voucher for Cross Country SSV
- 1000, - euro for Cross Country Cars Open
- 1000, - euro for Cross Country Cars Limited
- 1000, - euro for Cross Country Truck
- 1000, - euro for Extreme Cars Open
- 1000, - euro for Extreme Cars Limited
- 1000, - euro for Extreme Truck ≤ 7,5 t
- 1000, - euro for Extreme Truck > 7,5 t

The vouchers can be used for deduction of the entry fees in RBI Sport Rally Season 2023.

Vouchers are not transferable. They can only be used by the winners in the RBI Master Award. Decisive is the pilot of the Crew.

Vouchers cannot be exchanged for cash.

In addition, Sponsors vouchers/prizes will be given upon the decision of the Sponsor.
